Comments :

SBI (Mauritius) Ltd is maintaining adequate level of High Quality Liquid Assets (HQLAs) for LCR purpose. Our HQLA portfolio comprises of Cash, Unrestricted balances with Central Bank, Sovereign and MDB Bonds and BOM/GOM Bonds and Bills .

During the quarter ended March 2023, the consolidated quarterly average of monthly HQLAs stood at USD 105.85 Mio against the consolidated quarterly average of monthly estimated net cash outflows of USD 61.44 Mio, thus having LCR of 172.29 % on consolidated basis against a current minimum regulatory requirement of 100 %.

The main drivers of the net cash outflows are those associated with the bank deposits portfolios, borrowing from other financial institutions and cash inflows are mainly from loan repayments/maturities and from interbank bank lending to financial Institutions. On a quarter to quarter basis, though the LCR ratio decreased from 196.18 % in December 2022 to 172.29 % in March 2023, it remaining comfortably well above the minimum regulatory requirement of 100% .
